Pro-Life Laws Make a Real Difference

Examining Rhode Island's Pro-Life Legislation

Pro-lifers have heroically fought in court to overturn Roe v. Wade for over 30 years. While court battles get the glitzy media attention, it's easy to overlook the day-to-day work of slowing abortion-on-demand and saving lives that is done more quietly in state legislatures.

Michael J. New, a post-doctoral fellow at the Harvard-MIT data center, is the author of the Heritage Foundation study "Analyzing the Effects of State Legislation on the Incidence of Abortion During the 1990s." While studying data from all 50 states, Dr. New investigated the positive impact that passing protective laws had in reducing the number of abortions. When comparing the number of abortions in 1990 with the number in 1999, New concluded that these laws helped account for a drop of 17 percent in abortions in the 46 states that reported data for both years.

Let me quote the basic outline of what Dr. New did in his thoughtful profile of state legislation. "Examining state abortion data for every year from 1985 to 1999, and holding a variety of economic and demographic factors constant, the Heritage study examines the impact of four common types of pro-life legislation: parental-involvement laws, Medicaid funding restrictions, informed-consent laws and partial-birth-abortion bans," he wrote. In a summary of his study written for National Review online, New also attributes the reduction in the number of abortions to "the fact that pro-life legislators made considerable and lasting gains at the state level during the 1990s." Dr. New found that while all four types of pro-life legislation helped reduce the number of abortions, "restrictions on the Medicaid funding of abortions had the largest and most statistically significant impact." In addition, "The enactment of informed-consent laws resulted in statistically significant reductions as well."

RIRTL Creating Local Chapters

In order to facilitate passing pro-life legislation and to identify and support pro-life candidates during elections, it is imperative that we look for ways to increase our grassroots membership. Three New England states--Rhode Island, Maine, and New Hampshire--have limits on Medicaid funding for abortions with exceptions for the life of the mother, rape, and incest. This regulation was put into place in Rhode Island by Governor Garrahy in 1995 and has saved the lives of hundreds of babies over the years. Rhode Island and Massachusetts both have one parental consent law for women under 18 years old. Of the six New England states, only Rhode Island has passed a partial-birth abortion ban, though the law is not in effect. Rhode Island joins Maine,

Connecticut, and New Hampshire in a ban on assisted suicide.

Stem Cell Research 101

Stem cell research is probably the most misunderstood issue in the pro-life platform. A refresher about the basic facts of this issue can help life advocates dispel the myths and inaccuracies comonly repeated about this topic.

Stem cells are cells that can differentiate into other types of body cells. Scientists are using stem cells in research projects, hoping that such flexible cells will be the source of cures for debilitating illnesses and diseases. Because stem cells can form many different components of the human body, such as blood, tissue, and nerves, these newly created building blocks could be used to replace dying or diseased parts of a patient's body.

The two types of stem cell research are named after the sources of the cells. Embryonic stem cell research (ESCR) uses cells from embryos created through in vitro fertilization. Adult stem cell research (ASCR) uses cells obtained from plentiful non-embryonic sources such as bone marrow, fat, the placenta, and amniotic fluid.

This is a pro-life issue because the ESCR process of extracting the stem cells from the human embryo destroys the newly formed life. ASCR does not pose the same moral dilemma because adult stem cells can be removed without harming the donor.

Even though ESCR kills human embryos, some scientists claim the research should continue because ESCs have the potential to become all the different types of body cells. ASCs reproduce in kind, forming more specialized types of body cells.

As both forms of stem cell research continue, it is becoming evident that the original high hopes for ESCR were misplaced. To date, ESCR has not produced a single cure. ESCs cannot even be used in human trials because of the many problems revealed in mouse trials, including rejection by the recipient's immune system and the cells growing tumors.

ASCs, on the other hand, have successfully treated patients with autoimmune diseases such as multiple sclerosis as well as patients with damage to the spinal cord, cornea, cardiac tissue, and more - ASCs have been successfully used in treating over 70 medical conditions.

Rhode Island Right to Life opposes life-destroying embryonic stem cell research, but supports and promotes the exciting advances of adult stem cell research.

Federal Update

• U.S. Funding for International Abortion Providers Passed in Senate - On Sept. 6, the Senate voted to overturn the "Mexico City policy" that prevents international organizations providing abortions from receiving American aid. The Boxer Amendment overturning the pro-life policy was added to a State Department/Foreign Operations appropriations bill by Sen. Barbara Boxer from California. RI Senators Whitehouse and Reed voted in favor of the anti-life amendment. President Bush has promised to veto the bill, as he is faithful to do with all anti-life legislation.
